Tax exemption and Franchise Fee Reimbursement

- Manufacturers can receive tax exemption on any electric, natural gas or water usage they use to manufacture a product
 - Hospitals, schools, universities, government and other non-profits are 100% tax exempt for all utility usage
 - Apply everything 3 years
- City of Dubuque offers a franchise fee reimbursement at same state tax exemption level
 - Apply yearly with deadline in late June



Energy Efficiency - Rebates

Prescriptive (1-for-1)

- Fixed rebate amount
- VFDs, motors, chillers, etc.
- Business installs, sends invoice and rebate form to Alliant, receives check in mail or a deposit in their bank account

2024 Updates

- LEDs and HVAC rebates will go Mid-Stream
- Rebate goes to vendor/distributor and business receives a reduced upfront cost



Energy Efficiency – Business Energy Solutions

- Lighting and Refrigeration program
- Potential to have Alliant pay up to 70% of project cost
- Requirements of facility
 - Annual electric bill under \$100,000
 - -Less than 50,000 sq. ft.
 - Receive landlord approval if leased



Energy Efficiency – Custom Rebates

- Rebate based on energy savings specific to process or piece of equipment
- Rebate \$ levels:
 - -\$200/kw saved
 - -\$.10/kwh saved
- Examples:
 - Compressed Air, large VFDs and chillers, dust collectors, automation equipment, etc.
 - Increasing production or throughput can qualify



CASE STUDY

Custom Rebates

Laser Replacement

Business replaced an existing 4.5 kW CO2 laser with a new 8 kW fiber laser. The new laser will be able to increase the cut speed and through put. This will allow customer to reduce the run time on this laser.



Energy Savings 203,023.00 kWh/year 69.41 kW demand

Incentive: \$ 34,102.30



Energy Efficiency – Feasibility Study

Benefits

- A detailed analysis that quantifies the costs and benefits of the energyefficiency upgrades
- Business receives 50% of the pre-approved study cost, up to \$7,500

Requirements

- Study must be pre-approved by Alliant Energy
- Must be conducted in a building that Alliant Energy supplies the primary heating or cooling energy

Study examples

- Compressed air, Retro-commissioning, process water, etc.



Energy Efficiency – New Construction

Commercial

- Major renovations or new facilities
- Over 5,000 sq. ft and space is air conditioned
- Minimum \$.06/kwh for 5% savings. Up to \$.17/kwh saved

Industrial

- Major renovation, new facility or new manufacturing line
- Facility must be over 50,000 sq. ft. and 50% of electric usage must come from manufacturing process



Education

- Energy Audits
 - Benefits
 - Business receives customized energy information about their facility
 - Identified upgrades may be eligible for rebates
 - No additional charge to the business
 - Requirements
 - Facility must be larger than 20,000 square feet
- Energy Analytics
 - -Online tool which shows interval data (1 hour to 15 minutes)



Demand Response

- Requirements
 - Must have generators
 - -200+ kW of load
 - Can switch generator(s) on when Alliant Energy requests
- Benefits
 - Monthly bill credits of \$8.21/kW



Renewable Energy Programs

Community Solar

- Subscription based program which allows Alliant Energy customers to purchase a portion of a solar array.
- Cedar Rapids, IA array (first in Iowa)
- Next project will begin in 2025. Currently looking at lowa locations and anchor businesses

Customer Hosted

- Alliant will own, operate, and maintain a solar array on our business's land and pay a monthly lease payment for 20 – 30 years
- Business must own facility/land and must pay electric invoice

Business Support

MVEC demonstrates concern for the communities we serve by managing a Revolving Loan Fund that promotes growth and vibrancy in our region.

- Low interest, gap funding
- Loans up to \$200,000 for facilities and equipment; 7-10 year term
- Supports job creation and vital services in our communities
- For large-scale projects, there is potential to tap into additional USDA (REDLG) funding





Manufacturers Tax Credit

All customer types:

- Exemption Certificates must be renewed every three years.
 - o BHE provides 60-day notice
 - BHE cannot refund sales tax in lowa refund must be requested by customer from state
- Exemption certificates MUST be properly completed and signed to be accepted.

Manufacturing and Processing

- Information, Forms and instructions to calculate a fuel exemption
 - o <u>lowa Sales and Use Tax on Manufacturing and Processing | lowa Department Of Revenue</u>
 - Scroll down to Fuel Used in Processing
 - <u>Iowa Sales Tax Exemption Certificate Energy Used in Processing or Agriculture, 31113</u>

Franchise Fees

- Generally, no exemptions applicable to franchise fees if in city limits.
- Refunds can be obtained from City of Dubuque annually for period of July 1 through June 30
